AIKCU EMPLOYEE HEALTH INSURANCE

Members can join a self-funded employee health insurance program through the AIKCU Benefits Alliance, a collaborative health insurance purchasing organization serving AIKCU campuses. The Alliance operates under a jointly administered arrangement with Anthem Health Plans of Kentucky and Aspirant.

The Benefits Alliance became fully operational in 2007 and now serves 10 AlKCU institutions and one affiliate member. While the Alliance never guarantees against rising healthcare costs, participants have seen significant savings.

AIKCU MEP RETIREMENT PLAN

Members can participate in AIKCU MEP, a competitive multiple employer retirement plan sponsored by AIKCU.

MEPs allow employers to band together to take advantage of scale and efficiencies they cannot achieve on their own. The AIKCU MEP launched in June 2024.

This program allows members to provide enhanced retirement plans for their new and existing employees, while benefiting from potential cost savings, less burdensome administration, and streamlined operations.

The AIKCU MEP is administered by four plan providers. PlanPILOT is the 3(38) investment fiduciary, Millennium is the registered investment adviser, Pentegra is the 3(16) administrative fiduciary, and TIAA is the plan recordkeeper.
